# **Terms and Conditions**

## General

The promoter for the purpose of this competition (the "Competition") is PGA European Tour, a company limited by guarantee (registered no. 1867610) whose registered office is at Wentworth Drive, Virginia Water, Surrey GU25 4LX (the "Tour", "we", "us" or "our").

The Competition is governed by: (i) the terms and conditions set out below; and (ii) the European Tour Competition – Terms and Conditions, a copy of which can be found <a href="here">here</a> (the "T&Cs") (together, the "Terms and Conditions"). By entering the Competition, in accordance with the mechanics set out below, you are deemed to have accepted and will be bound by the Terms and Conditions.

## **How to Enter**
