### Admission

- 26. Tickets sold by or obtained from any other source will have NO validity.
- 27. PGAET reserves the right to require each Ticket Holder to produce all or part of the following: a photo ID that accurately resembles the Ticket Holder, date of birth, first and last name, postal address and e-mail address or telephone number or other information if applicable. ## Refunds

Neither PGAET nor its respective subsidiaries (the "European Tour Group "), will assume any liability arising from the removal, cancellation, abandonment, postponement or repetition of the Event due to an unforeseeable and insurmountable action on the part of a third party or a case of force majeure as defined by Article 1218 of the French Civil Code or recognized by the French courts, even in the event that the cancellation, abandonment, postponement or repetition of the Event would be detrimental to the Ticket Holder. As a result, no entity of the European Tour Group will be liable to pay compensation or damages in this regard.
- 41. PGAET will not refund the purchase price of the Ticket (and will not be liable for any other sums) in cases where the part is cancelled or partially cancelled or postponed due to an

- 43. In the event that the game is postponed until the following Monday, the Tickets issued for Sunday will be valid for the additional day of activity (provided that the Site is suitable for spectators).

This data will not be transferred to third parties for advertising or commercial prospecting purposes without the consent of the Ticket Holder. PGAET may not sell or license any personal data collected from a Ticket Holder without their express prior consent.

48. With the express consent of the Ticket Holder, information about him or her may be disclosed to members of the European Tour Group and the use of such data will be governed by PGA European Tour Group's privacy policy on:

The other data requested is simply to improve the Ticket Holder's experience, and is therefore optional, and the Ticket Holder is therefore not obliged to provide it.

52. The data collected is stored in a secure location to which access is restricted to authorized employees. All electronic backup procedures for the data thus collected must comply with French legislation on individual data.

53. The personal data collected from the Ticket Holder are kept for the time necessary and as long as the person concerned has not requested their destruction by PGAET. In any case, personal data is not kept for more than 3 years after the end of the Event.

54.
